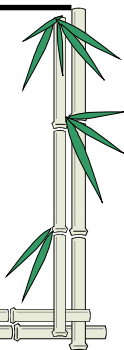

I wish to thank you for your e-mail as communication is the key to achieving positive results.

The most important thing is a realistic obtainable goal i.e. revision of the Chow Chow Standard to clarify and update, reflecting today's world. Then with good communication a workable draft should be possible.

It has been 4 years and a lot of hard work by all to come to a position where is it possible to see a conclusion in the near future. However, the National members were not aware of the status of progress and it was in the best of interests that the information be circulated for opinion from the membership. Hopefully a good response will be the result. The draft that was printed in the last National Newsletter can be used to combine the responses, your input and that of National, we can try to reach a consensus for a final draft to

be voted on. Progress can only be achieved if momentum is maintained

I have noted your objections \opinions and assure you that if an omission was made in the draft it was unintentional and will be most certainly be contained in the revisions to the final draft. The proper wording and format is being reviewed by Gail Forsythe, who is a long time Chow Breeder, Conformation Judge, National member of CCFC, and a lawyer by profession, who writes legal opinion for Dogs In Canada.

As to your opinion that I have exceeded the authority of President, I take exception to this and refer to the constitution of the CCFC. The objectives are clearly stated and this is main purpose of a standard revision. It is a National exercise and not one of Sections, or Ontario versus the rest. I believe that all should be listened too and progress should be a positive experience. If we can move on from this point perhaps a conclusion can be achievable in the near future.

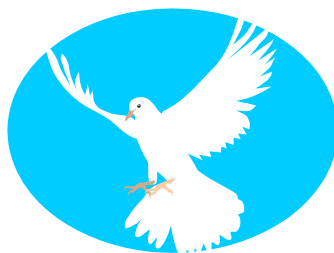

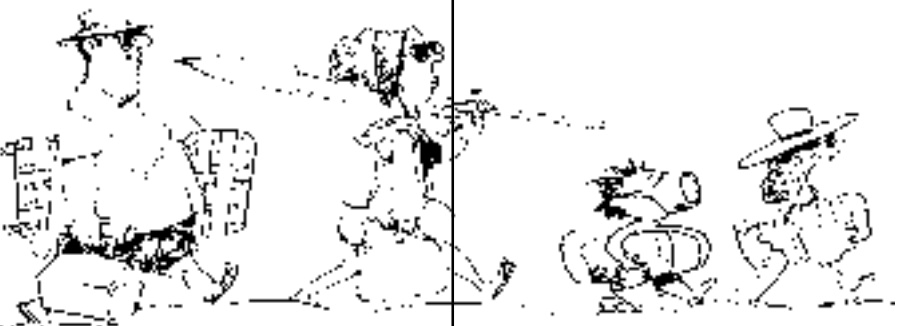

Thoughts by Shannon Sheer...

There have been many complaints lately on the decline of entries at the more popular shows in our areas. I do not feel this is due to judging panels as some people state. Some shows are geographically very close to others and with the economy the way it is, people are choosing which shows to do, rather than just entering from every premium list received, as we used to do.

In a recent conversation I found out that for two people to attend, say, a Brandon, Manitoba show from the Alberta area, they were looking at spending easily \$600 for the weekend. I don't know too many people who can shell that kind of money out week after week to show their own dogs. For us prairie dwellers, Brandon used to be a welcome show to do. Even though it is a twelve-hour drive, we did it, as it was one of the first shows of the year out here. They have since changed their dates from January to March, which makes it a little bit easier on those of us who drive those treacherous highways in the mid-winter.

Of course there is always air travel. Some of the seat sales have been incredible and there is no way we could drive to those shows with the fares that are available to us currently. However, once again we are finding that air travel may soon become nonexistent to those of us who rely so heavily upon it. With the merging of Canadian and Air Canada, we have found ourselves with few choices on flight times as so many schedules have been changed. Many people are finding it very difficult to fly with the dogs. The general consensus is that the airlines would rather do without dog travel.

I have nothing but praise for Canadian Airlines, as they truly bend over backwards to help us get our charges to the shows. However when flying Air Canada, it seems that each airport has a different set of rules. If you came with three dogs, then why is returning with three dogs such an impossibility? I have heard horror stories of how one handler had to put her charges on as cargo, not excess baggage, just to get to the show. Now, a bill of \$210 for three dogs seems feasible. This gal wound up paying cargo charges of up to \$300 one way for each crate.

What the airlines are now trying to do is to stop the airline travel of commercial dogs. This means dogs which are travelling for shows, racing, etc. If you are travel

ling with your family pet on a holiday, then that is alright. The minute they hear "show dogs", they tend to get in a tizzy over it.

Another friend tried to ship her dog out of Prince George to be bred. When the cargo agent found out the reason, they refused to ship the bitch as they no longer "carried bitches in season for reasons of breeding purposes." Now who came up with that rule? And why was it only isolated to the Prince George area? My friend took her dog home, went back the next day, different cargo agent, didn't mention a word about her dog being in season, and away she went, hassle free.

What will become of the dog population if we are no longer allowed air travel? There will be no more national specialties in the US for us; we will not be able to compete at the prestigious Ottawa Show of Shows or Credit Valley or Lower Mainland Dog Fanciers. Will the Westerners just have to give up the idea of ever having a campaign dog? Heaven knows that WE can't campaign solely on the amount of shows that we have out west. We will no longer be able to ship animals for breeding purposes, we would no longer be able to sell puppies to those homes who have desperately been waiting for just the right puppy.

This is where we are heading in the future. Canadian has assured me that the airline travel will remain the same quality

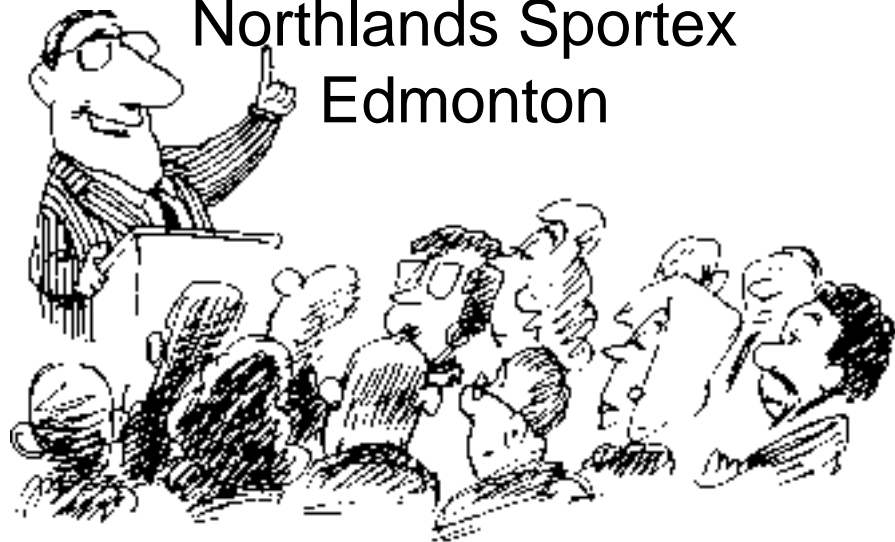

From which country did the Sapsalgae and Chindogae originate?

Two War Dog Memorials will be built to honor dogs who served in Vietnam. The first was unveiled on President's Day, 2000. Where is it?

The Sapsalgae and Chindogae originate from Korea. "Each country has dogs of its own, that is, breeds indigenous to the country that are domesticated and developed over centuries to limited variability in the genetic sense. Germany has Shepherds and Dobermans, England has Collies and Terriers, and Korea has Sapsalgae and Chindogae."

There are two war dog memorials planned to honor dogs who served in Vietnam. The first was unveiled on President's Day 2000 at March Field Air Museum - March Air Force Base, Riverside, California.

with Air Canada that we have all come to love. With the combined efforts of John Scott, Patty Archibald, Sandra Roach and Kathy Miller, the folks at Canadian are absolutely fantastic with dog care and travelling arrangements coming out of the Calgary International airport. So for those of you flying with your dogs, if we wish to keep our current status with dogs and air travel, please remember to be courteous while at the airport. If they can't send the dogs you have with you on one plane, don't get upset. They do try to do their best. I usually have waited no more than two hours for the remaining canines to arrive at their destination.

The whole deal in this situation is compromise. Phone ahead and let the agents know that you will be travelling with dogs, do not show up at the airport with a surprise for them. Remember at Christmas time live cargo is secondary to Canada Post. If the cargo is full of mail, then you have no choice but to wait until the next available flight. Be prepared to pay the extra baggage charges if you are carrying a set of wheels, a grooming table, two suitcases and a tack box. Some airlines charge for this, and others do not. It just depends on how full the planes are.

With the joining of our two major airlines, the flights now operating are usually doing so at a high passenger rate. If we all work together, hopefully we will still be in the current situation of air travel with our dogs.

Doggie Trivia

Where is the Isle of Dogs?

The Isle of Dogs lies in the loop of the River Thames, East London, England. How the former marshland know as Stepney Marsh became known as the Isle of Dogs is legend. The most popular theory is that, when the kings and queens of England had their royal palace across the river at Greenwich, they kept their hunting dogs here; sailors passing in their ships heard the dogs barking and so named the place the 'Isle of Dogs'.

If your dog has "Ringworm", what does he have?

Ringworm (dermatophytosis) is a fungus, not a worm. The term "ringworm" comes from the erroneous belief that the skin lesions are caused by a worm that burrowed under the skin.

What is Psychogenic Polydipsia?

Excessive thirst in the absence of an underlying medical disorder may also be caused by psychological disturbances. Psychogenic polydipsia is the term used to describe excessive drinking with a psychological

cause. It is an expression of anxiety associated with, for example, the addition of a new pet.
